This addendum is being issued to the contract for CONSTRUCTION ON STATE HIGHWAY IN MENDOCINO COUNTY NEAR LAYTONVILLE FROM LONG VALLEY CREEK BRIDGE TO RAMSEY ROAD AND FROM 4.1 MILES NORTH OF HUNTSMAN WAY TO 0.2 MILE NORTH OF BELL SPRINGS ROAD.

In the Special Provisions, Section 15-2.02B(3)(a), "General," is replaced as follows:

"Schedule cold planing activities so that not more than 24 hours elapses between the time the pavement is cold planed and the HMA is placed."

In the Special Provisions, REVISED STANDARD SPECIFICATIONS DATED 07-18-14, is replaced with REVISED STANDARD SPECIFICATIONS DATED 10-17-14 as attached.
