



Project Initiation Document (PID) Committee Charter

Background	This Charter is intended to establish a mutual cooperative effort between internal and external stakeholders for the improvement of the PID program. The mission of the PID Committee is to: <i>“Improve both the effectiveness and efficiency of the Project Initiation Document (PID) program and coordinate PID efforts internally and externally.”</i>
Purpose	The purpose of the PID Committee is to make key decisions toward implementing improvements to increase the effectiveness of the PID Program.
Desired Goals	While the PID Committee will serve to meet multiple objectives, its primary objective is to reaffirm the purpose of PIDs and implement the recommendations identified in the PID Strategic Plan that reduce the cost and time of producing PIDs. Other objectives include assisting the Office of Project/Scoping Coordination (OPSC) in implementing other recommendations to improve the overall PID program and approving future PID strategic plans. The PID Committee also serves to coordinate PID efforts internally and externally, and to ensure implementation of all Caltrans Deputy Directives into the PID process.
Members	<p>The PID Committee is structured into three groups: the PID Working Committee (also known as PID Committee), the PID Steering Committee, and the existing Caltrans Project Delivery Advisory Committee (PDAC). Refer to Appendix A for additional information on the structure of the PID Committee.</p> <p>The PID Committee and Steering Committee team members include representatives from Caltrans Headquarters (HQs), Caltrans districts, and regional and local agencies. Refer to Appendix B for the roster of PID Committee team members.</p>
Frequency of Meetings	<ul style="list-style-type: none"> • The PID Committee will meet quarterly or more often as needed. • The PID Steering Committee will meet as needed.
Roles and Responsibilities	<ul style="list-style-type: none"> • The PID Committee will make recommendations to the PID Steering Committee and Caltrans PDAC of the strategies identified to improve the PID Program through the annual update of the PID Strategic Plan.
Reporting Structure Input to Board	<ul style="list-style-type: none"> • The PID Committee will assist OPSC in making key decisions toward implementing recommendations to improve the overall PID program and recommending approval of future PID strategic plans to the PID Steering Committee. • The PID Steering Committee will guide the direction of the Working Committee, review PID Committee recommendations, and as appropriate, elevate any recommendations for final approval to the Caltrans PDAC.
Decision Process	<ul style="list-style-type: none"> • The PID Steering Committee will oversee implementation of PID Program policy, and will elevate executive-level decisions to the Caltrans PDAC.


